



## MEMBERSHIP CATEGORIES:

### GENERAL MEMBERSHIP INFORMATION:

- 1) Definition of Family: Husband, wife and dependent children.
- 2) Dependent Children: Ages 22 and under if in school; 18 and under if not in school.
- 3) Family Memberships (Golf and Pool): Includes (2) domestic people in a personal relationship who reside in the same residence. Documentation must be provided to verify address.
- 4) Grandchildren are considered to be dependents.
- 5) For those grandparents who have a Family membership, grandchildren ages 22 and younger will be considered to be dependent children.
- 6) All golfing memberships require a one year minimum commitment. Some memberships offer a two-year commitment to waive the \$500.00 initiation fee; however, the initiation fee for a Social membership cannot be waived.
- 7) The Greene Hills Club is a non-profit corporation, founded in 1967. The Board of Directors makes every effort to keep dues at a minimum level that is compatible with satisfactory Club operation. The budget is evaluated on a yearly basis.

**Voting Memberships: All monthly golf membership rates listed below include a \$4/month range fee.**

New Full Family (1<sup>st</sup> year: \$204.00/mo., 2<sup>nd</sup> Year: current monthly rate)

New Full Single (1<sup>st</sup> year: \$155.00/mo., 2<sup>nd</sup> Year: current monthly rate)

To continue to grow the membership of Greene Hills, a New Full Family or Full Single membership will be offered at a first year discounted dues structure. A New Member is defined as a person or

family that has never been a member of Greene Hills Club or has previously been a member of the Club, resigned in good standing and has also not been a member for 12 consecutive months prior to signing a two year agreement. The New Full Family member will receive discounted dues for the first year of \$204 (current dues \$246) and a New Full Single member will receive discounted dues for the first year of \$155 (current dues \$199.) The second year, and continuing thereafter, dues will be charged at the current yearly rate. There will be an early termination fee for any new full member that leaves the Club before the two year commitment is completed. The new member must remain in the same membership category for two years.

### Associate Membership

1. **Single (\$104/month)** — Receives two 18 hole rounds of golf per month for \$100.00, plus the current \$4.00/month range fee; includes access to all Club facilities and social events. Discount rates for green fees apply thereafter. Golf carts are not included.
2. **Family (\$154/month)** — Receives three 18 hole rounds of golf per month for \$150.00, plus \$4.00/month range fee; includes access to all Club facilities and social events. Discount rates for green fees apply thereafter. Golf carts are not included.

### Multi-Generational Membership: Family (\$155); Single (\$125)

In an effort to bring more families into GHC, a Multi-Generational Membership is offered. One member must hold a FULL FAMILY MEMBERSHIP which will allow the member to bring in other immediate family (i.e. father, son, daughter, grandchildren) at a discounted membership rate. Examples: hold a Full Family membership at \$246.00 and other family members would be able to join Greene Hills at the following rates: \$155.00 for Full Family or \$125.00 for a Full Single membership. These rates include the current \$4.00/month range fee. The member holding the Full Family membership will be responsible for all late and outstanding charges made by the member holding the discounted membership.

### Family (\$246/month)

Includes all activities and facilities of the Club for the entire family: husband, wife, and dependent children - seven days a week. Grandchildren, ages 22 and younger will be considered dependent children for those grandparents holding a family membership. In addition, family memberships will include domestic partners - 2 people in a personal relationship who reside at the same residence. Documentation must be provided to verify address.

### Single (\$199/month)

Includes all activities and facilities of the Club, seven days a week, for the individual member only.

### 2nd Club Membership Family (\$154) Single (\$104)

Must be a current FULL member at another private club. Includes the same privileges as Family and Single memberships. Proof of membership at the first club must be provided.

### Weekday Family (\$181/month) Single (\$155/month)

Includes full use of golf facilities for family or individual during weekdays only (Mon-Fri). Major holidays that fall on weekdays shall be considered weekends. This membership includes full use of all other Club facilities, seven days a week.

### Young Adult Family (30-39 years old) (\$181/month)

The senior member of the family must be 30-39 years of age. For those who qualify, this membership includes participation in all activities and use of all facilities at the Club for the entire family: husband, wife, and dependent children, seven days a week. When the oldest member of this membership turns 40, the membership and monthly dues rate change to a Full Family membership.

### Young Adult Single (30-39 years old) (\$155/month)

For those between the ages of 30 and 39; includes all activities and facilities of the Club, seven days a week for the individual member only. When the member turns 40, the membership and monthly dues rate change to a Full Single membership.

### Young Adult Family (18-29 years old) (\$155/month)

The senior member of the family must be 18-29 years of age. Same benefits as Young Adult Family (30-39) years. When the oldest member of this membership turns 30, the membership and monthly dues rate change to Young Adult Family (30-39) years old.

### Young Adult Single (18-29 years old) (\$125/month)

Same benefits as Young Adult Single 30-39 years. When the member turns 30, this membership and monthly dues rate change to Young Adult Family (30-39) years old.

## Corporate

### Social (\$84/month; \$500 initiation fee)

Includes all activities and full use of swimming and tennis facilities of the Club for the entire family. Golf may be played by paying the appropriate 'Accompanied Guest' greens fee. The \$500.00 initiation fee for this membership cannot be waived.

### Non-Resident (\$230/year)

This membership is for individuals who do not have a full-time residence in Greene County and live outside a 40-mile driving radius of Greene Hills Club. Non-resident members have the right to all Club facilities and activities, but must pay applicable daily guest fees.

## Military

There is no Initiation Fee for active duty military. This membership allows active duty military personnel to select a membership without a one year commitment.

## Non-Voting with Year Round Access

### Youth Golf (\$240/season; may be extended for \$50/month)

For those individuals 18 years and younger. Includes use of golf course Memorial Day Weekend through Labor Day. May play Monday through Thursday anytime and on weekends and holidays after 2:00 pm, depending on tee time availability. Also includes range balls. Pool may be used by paying the daily guest fee. This membership may be extended on a monthly basis for an additional fee.

### Tennis Family (\$504/year) Single (\$378/year)

Offers the use of the tennis courts, year-round, for family or individual. No voting privileges and no preferred rate for golf. May use pool by paying the daily guest fee. Billed in March and September of each year.

## Non-Voting Seasonal Access Memorial Day Weekend through Labor Day

### Family Pool and Tennis (\$750/ \$695 if paid by April 30<sup>th</sup>)

Includes the use of the pool and tennis courts only for the entire family from Memorial Day Weekend through Labor Day. Use includes weekdays, weekends, and holidays. No voting privileges and no preferred rate for golf..

### Single Pool and Tennis (525; \$495 if paid by April 30<sup>th</sup>)

Includes the use of the pool and tennis courts only for individual from Memorial Day Weekend through Labor Day. Use includes weekdays, weekends, and holidays. No voting privileges and no preferred rate for golf.

### Weekday Pool and Tennis Family (\$525, \$495.00 if paid by April 30<sup>th</sup>) Single (\$375, \$350 if paid by April 30<sup>th</sup>)

Includes the use of the pool and tennis courts only for family or individual from Memorial Day through Labor Day during weekdays only. Major holidays that fall on weekdays are included. No voting privileges and no preferred rate for golf.

### Youth Pool

This pass is available for individuals 18 years and younger, with use of the pool 7 days a week from Memorial Day Weekend through Labor Day. To be left unaccompanied inside the pool area fence or in the diving area, all children under the age of 18 must pass a proficiency test. Children under ten years of age must be accompanied by a person 13 years of age or older, under whose custody they remain at all times. A caregiver pass may be obtained for \$40/month. Caregivers may not be immediate family members (parents, brother, sister.)

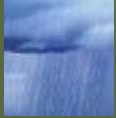
